Head of School (HoS) report shared by Leslie

- Leslie shared that the Chair (Nina and David Jones) for auction have been selected
- Annual fund will be chaired Laura Ybarra
- Auction February 28, 2025
- DSS visit had no deficiencies
- Staff Updates- Lisa Wheeler will be leaving for full-time position at Heathwood Hall
- Vera will come back on January 6th
- Tina Davis will be covering needs and will also be helping with aftercare and covering for Vera.
- Sarah Barnett will take over Vera's communication and staffing
- Campus signs have been ordered to better mark areas that families need to navigate
- Michael, Leslie, and Bridgett with met with a representative from SCDOT about additional signage
- Discussion was had about families parking in neighbors and walking up.

Finance Updates shared by Leslie

- Semester payments will begin being paid in Novembers
- January is a bigger financial surge with enrollment contracts
- Mary moved to vote on releasing a family that submitted a letter requesting to be let out
 of their contract for the second semester due to a family move for jobs. Bridgett Shealey
 seconded the motion and the board unanimously approved releasing them from their
 financial responsibility for the second semester.
- Financial aid: staff/child, sibling discount, and tuition assistance
 - Sibling discount=\$5,000
 - Staff/child= will also drop
 - Tuition Assistance/Financial keeping it at= \$74,825

- families =\$40.000
- TADS processes financial aid paperwork
- Last year 13 applied range was 15-50%
- Ginny Warren made a motion to approve \$40,000 for TADS to use for Tuition Assistance/financial aid. Dave Barbeau seconded the motion. The board unanimously approved the motion.
- Tuition increase discussion: suggestion 3%. Bridgette Shealey made a motion to approve a 3% tuition increase. Dave Barbeau seconded the motion and the board unanimously approved the 3% tuition increase for the 2025-2026 school year.
